



## EXECUTIVE ORDER NO. 014 Series of 2021

### RECONSTITUTING THE GENDER AND DEVELOPMENT MONITORING AND EVALUATION (GAD M&E) TEAM IN THE IMPLEMENTATION OF THE MAGNA CARTA OF WOMEN (R.A. 9710) IN THE LOCAL GOVERNMENT UNIT OF MARCOS, ILOCOS NORTE

WHEREAS, Republic Act No. 7160 or the Local Government Code of 1991 Section 16 and 17 thereof mandates local government units to provide basic services and implement programs, projects and activities to support the general welfare of the people;

WHEREAS, Joint Memorandum Circular No. 2013-01 issued by the Philippine Commission on Women (PCW), Department of the Interior and Local Government (DILG), Department of Budget and Management (DBM) and National Economic Development Authority (NEDA) provides the guidelines on the localization of the Magna Carta of Women and to monitor and evaluate advancement of gender mainstreaming efforts under the LGU's regular programs, projects and activities;

WHEREAS, pursuant to Section 36 of Republic Act No. 9710, otherwise known as the Magna Carta of Women (MCW), all government departments, including their attached agencies, offices, bureaus, state universities and colleges, government-owned and controlled corporations (GOCCs), local government units and all other government instrumentalities shall adopt gender mainstreaming as a strategy to promote women's human rights and eliminate gender discrimination in their systems, structures, policies, programs, processes, and procedures;

WHEREAS, following the above-stated constitutional mandate, there is a need to reconstitute the GAD M & E Team of the Local Government Unit of Marcos to replace members who are no longer connected to the LGU.pp

**WHEREFORE**, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, **I, ANTONIO V. MARIANO**, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby reconstitute the GAD M& E of the Local Government Unit of Marcos, Ilocos Norte and order the following:

**Section 1.** Composition. The GAD M&E Team shall be composed of the following:

1. Evaluate the outcomes of the LGU GAD policies, programs and projects; and
2. Submit a GAD evaluation report to the DILG Regional Office at the end of the Local Chief Executive's three-year term.

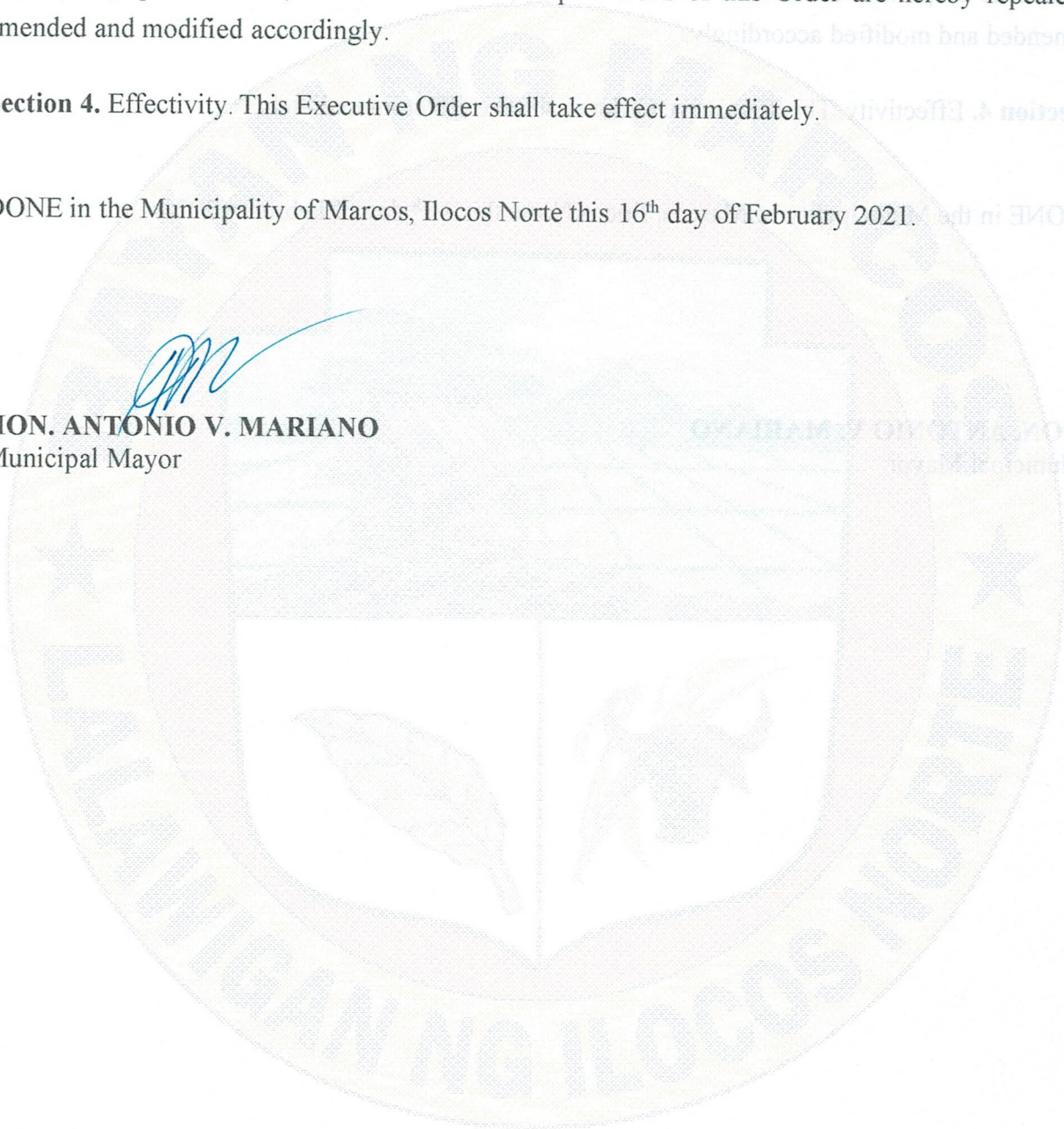
