MANDATING ALL BARANGAYS OF THE MUNICIPALITY OF MARCOS TO ORGANIZE/REORGANIZE THEIR BARANGAY NUTRITION COMMITTEE

WHEREAS, Section 15 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, states that every Local Government Unit shall exercise the powers expressly necessary, appropriate, or incidental for its efficient and effective governance;

WHEREAS, Section 15, Article II of the 1987 Philippine Constitution provides that the state shall protect and promote the right to health of the people and instill health consciousness among them;

WHEREAS, in 1978, Presidential Decree 1569 tasked the Barangay Nutrition Committee to train the barangay nutrition scholar to be responsible for delivering nutrition services and related activities to the village;

WHEREAS, there is an existing Executive Order (EO No. 002) Reconstituting Municipal Nutrition Action Council of the Municipality of Marcos;

WHEREAS, as per DILG MC NO. 89-47 there is a need to organize/reorganize the Barangay Nutrition Action Committee.

NOW THEREFORE, I, **ANTONIO V. MARIANO**, Municipal Mayor of Marcos, Ilocos Norte by virtue of the powers vested in me by law do hereby order to organize/reorganize the Barangay Nutrition Committee of the Municipality of Marcos.

Section 1. Composition. The Barangay Nutrition Action Committee shall be composed of the following:

Section 2. FUNCTIONS OF THE BARANGAY NUTRITION COMMITTEE

- a. Formulate Barangay Nutrition Action Program;
- b. Coordinate the Nutrition activities of the barangay;
- c. Organize the Barangay Networks;
- d. Prepare spot map of the barangay;
- e. Conduct operation timbang under the supervision of a health RHU;
- f. Organize specific groups to implement nutrition intervention activities and assess progress;
- g. Hold regular quarterly meetings to monitor performance;
- h. Disseminate proper information on the national policy and program, including their local program to encourage the active participation of their constituents on physical fitness and sports activities;
- i. Assist in the identification, recruitment and training of gifted and talented athletes; and
- j. Perform other functions deemed necessary to promote and implement the National Policy Program.

Section 3. Penalties. All penalties found violating the provisions of this order shall be subjected to administrative sanctions, without prejudice to prosecution of criminal action(s), if probable cause exists;

Section 4. Repealing Clause. All executive orders, proclamations, rules, regulations, previous issuances or parts thereof, inconsistent with the provisions of this Order are hereby repealed, amended and modified accordingly.

Section 5. Effectivity. This Executive Order shall take effect immediately.
