EXECUTIVE ORDER NO. 018 Series of 2021

AN ORDER CREATING THE SCHEDULE OF COLLECTION OF GARBAGE IN THE MUNICIPALITY OF MARCOS, ILOCOS NORTE

WHEREAS, the Local Government Code stipulates that the provision of basic services and facilities shall be provided by the LGUs. The services include the provision of solid waste disposal system or environmental management system and services or facilities related to general hygiene and sanitation.

WHEREAS, Republic Act 9003, otherwise known as Ecological Waste Management Act of 2000 was enacted declaring the policy of the government to "adopt a systematic, comprehensive, and ecological solid waste management program."

WHEREAS, provided in RA 9003 and its implementing rules and regulations are mandates and schedules of implementation to be undertaken by the LGU's. the most important of these include the creation of the Solid Waste Management Board.

WHEREAS, it is essential for us to segregate waste so that we can protect everybody's health. If these wastes are segregated properly, then the risk of cuts or bruises that our garbage collectors may experience will be avoided.

WHEREAS, every household is encourage to have four (4) receptacles for every garbage, one for biodegradable, recyclable, residuals and special waste. Each receptacle must be properly labeled. Once your waste are segregated, then it will be easier for the garbage collectors to recycle wastes. They can easily handle the wastes that will go to the recycler or to the incinerator/machine.

WHEREAS, for the proper implementation of garbage collection there is a need to create the schedule for collection of each garbage for appropriate disposal.

NOW THEREFORE, I, ANTONIO V. MARIANO, Municipal Mayor of Marcos, Ilocos Norte by virtue of the powers vested in me by law do hereby order the creation for the schedule of collection of garbage in the Municipality of Marcos.

SECTION 2. TYPES OF WASTE

BIODEGRADABLE WASTE - Biodegradable material contains food waste like vegetable and fruit peels, dead plants, egg shells, chicken, paper plates, paper cups, tissue paper and wet paper and the like.

RECYCLABLE WASTE - Typical materials that are recycled including iron and steel scrap, aluminum cans, glass bottles, plastic bottles and plastic utensils and the like.

RESIDUAL WASTE - Non-hazardous waste material that cannot be re-used or recycled and needs to be sent to energy recovery or disposal. Residual waste includes styro foams, candy wrappers, plastic foil/food wrappers, tetra packs and the like.

HAZARDOUS WASTE - Hazardous wastes are classified on the basis of their biological, chemical, and physical properties. These properties generate materials that are either toxic, reactive, ignitable, corrosive, infectious, or radioactive. Toxic wastes are poisons, even in very small or trace amounts. Hazardous waste includes batteries, computers, fluorescent bulbs,mercury thermometer, nail polish, chemicals used by beauticians, muriatic acid, chlorine, pesticides,insecticides and the like.

SPECIAL WASTE - used disposable masks, used PPEs, used syringes or waste from the hospital.
