RECONSTITUTING THE MUNICIPAL ANTI-DRUG ABUSE COUNCIL (MADAC) OF THE LOCAL GOVERNMENT UNIT (LGU) OF MARCOS, ILOCOS NORTE AND DESIGNATING THE LGU'S MADAC FOCAL PERSON

WHEREAS, the Local Government Code of 1991 provides that Local Government Units shall pursue undertakings to improve public moral and maintain peace and order;

WHEREAS, drug abuse is one of the major problems in our society, especially among the youths, thereby posing threats to the peace and order situation;

WHEREAS, the national government, through several issuances has enjoined the local government to support the fight against illegal drugs and work for drug-free communities;

WHEREAS, Joint Memorandum Circular No. 2018-01 dated May 21, 2018 by the Department of the Interior and Local Government (DILG) and the Dangerous Drugs Board (DDB) was issued as implementing guidelines on the functionality and effectiveness of Local Anti-Drug Abuse Councils;

WHEREAS, the municipal government, in accordance with the national thrusts, felt the need to reconstitute the Municipal Anti-Drug Abuse Council (MADAC) that will effectively formulate, recommend, coordinate, implement and monitor measures, programs and activities that will ensure a drug-free Marcos;

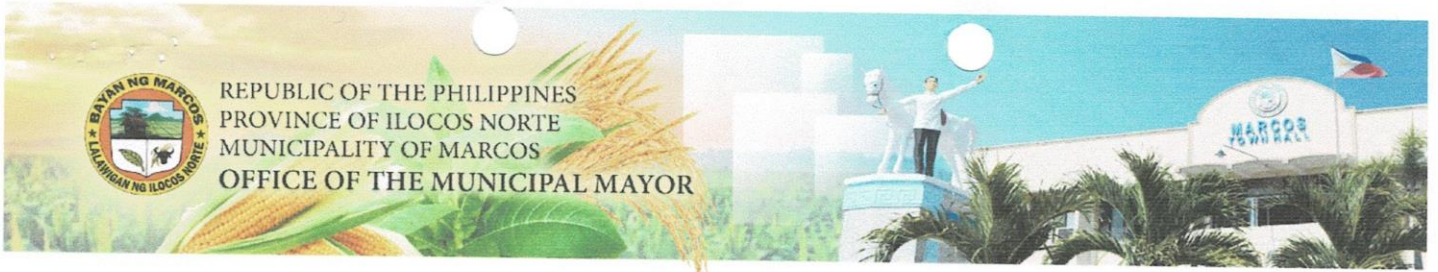
WHEREAS, there is a need to reconstitute the MADAC in order to update its membership;

WHEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, **I, ANTONIO V. MARIANO**, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby reconstitute the Municipal Anti-Drug Abuse Council (MADAC) and order the following:

Section 1. Composition. The MADAC shall be composed of the following:

Section 2. Functions. The MADAC shall have the following functions:

1. Convene concerned organizations or sectors in the cooperative planning, implementation and evaluation of various programs on drug abuse prevention and control.
2. Provide effective mechanism for coordination and alignment of existing services and programs that will complement planned of future programs.
3. Submit monthly monitoring report to the Provincial Anti-Drug Abuse Council.
4. Conduct information and education campaign that would ensure the participation and involvement of the entire community in the implementation of drug abuse prevention and control.
5. Institute mechanism to obtain support from all stakeholders by way of recruitment of volunteers, technical support, facilities and financial grants that would assist in addressing comprehensively the drug problem in the municipality.
6. Prepare a confidential watch list of drug users and pushers found in the LGU's area for verification leading to the arrest and filing of appropriate charges.
7. Recommend to the Sangguniang Bayan, the allocation of budget for the effective implementation of the drug prevention programs and activities.
8. Submit to the Local Chief Executive periodic report on the implementation of drug prevention programs and other related activities.
9. Perform such other functions as may be required by competent authorities to ensure a drug-free Marcos.

The MADAC Focal Person shall have the following functions:

1. Ensure the compliance and enforcement of the Dangerous Drugs Board (DDB) Regulations on voluntary surrender of Drug Users and Dependents.
2. Coordinate with the appropriate service provider to ensure compliance with the prescribed intervention.
3. Perform such other functions as may be required by law and competent authorities.

Section 3. Functionality Indicators. The MADAC shall be assessed in the following areas:

1. Organization
2. Meetings
3. Policies, plans and budget
4. Accomplishment
