



EXECUTIVE ORDER NO. 031

AN ORDER PLACING SITIO SINAMAR BARANGAY ELIZABETH, SITIO CADUGOLAN (1 HOUSEHOLD AFFECTED) BARANGAY PACIFICO, SITIO AURORA (2 HOUSEHOLDS AFFECTED) BARANGAY VALDEZ, SITIO BANNUAR (1 HOUSEHOLD AFFECTED) BARANGAY DAQUIOAG, SITIO SOUTH KURIPAT (2 HOUSEHOLDS AFFECTED) BARANGAY LYDIA AND SITIO SAN CARLOS (2 HOUSEHOLDS AFFECTED) BARANGAY ESCODA, MARCOS, ILOCOS NORTE UNDER ENHANCED COMMUNITY QUARANTINE (LOCKDOWN).

WHEREAS, Section 16 of the Local Government Code of 1991 mandates the Local Government Units to, among others promote the health and safety of their constituents;

WHEREAS, President Rodrigo Roa Duterte through Proclamation No. 922 s. 2020, declared a state of public health emergency due to the rapid proliferation of COVID-19 in the country;

WHEREAS, Residents of Marcos, Ilocos Norte was reported to be in contact with COVID-19 Positive Case Nos. IN-C1935, IN-C2141 and IN-C2145;

WHEREAS, Contact Tracing was conducted which resulted to the identification of residents from One (1) Sitio of Barangay Elizabeth, Sitio Cadugolan (1 Household Affected) of Barangay Pacifico, Sitio Aurora (2 Households affected) of Barangay Valdez, Sitio Bannuar (1 Household affected) of Barangay Daquioag, Sitio South Kuripat (2 households affected) of Barangay Lydia and Sitio San Carlos (2 Households Affected) of Barangay Escoda to be exposed to the positive COVID 19 cases;

WHEREAS, there is a need to impose localized lockdown in the above-mentioned areas for contact tracing purposes and to prevent the spread of the COVID-19;

WHEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, **I, ANTONIO V. MARIANO**, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby order the following:

Section 1. Declaration of Enhanced Community Quarantine (Lockdown) to the following:

BARANGAY ELIZABETH: SITIO SINAMAR

BARANGAY PACIFICO: SITIO CADUGOLAN (1 HOUSEHOLD AFFECTED)

BARANGAY VALDEZ: SITIO AURORA (2 HOUSEHOLDS AFFECTED)

BARANGAY DAQUIOAG: SITIO BANNUAR (1 HOUSEHOLD AFFECTED)

BARANGAY LYDIA: SITIO SOUTH KURIPAT (2 HOUSEHOLDS AFFECTED)

BARANGAY ESCODA: SITIO SAN CARLOS (2 HOUSEHOLDS AFFECTED)

Section 2. Policy Guidelines of Enhanced Community Quarantine (Lockdown). Pursuant to the declaration of Enhanced Community Quarantine to the six (6) Sitios of the Six (6) Barangays, the residents of those sitios are ordered and directed to obey, follow and abide strictly to the following policies and guidelines:

A. MANDATORY HOME QUARANTINE. All residents of the affected Sitios during the effectivity of this order shall stay at home and movement outside their home shall be allowed only for purposes of accessing basic necessities. Provide that only one member of the household is allowed to go out for this purpose except:

- Those which require medical attention and one companion such as patients undergoing dialysis, cancer patients and other emergency patients are allowed to attend to their medical necessities;
- Health workers residing in the said areas except identified contact;
- Officers of the PNP, AFP and other government workers rendering emergency frontline service except identified contact;
- Service workers who are working in pharmacies, drug stores and death care services except identified contact;

B. COMPLETELY NO MASS GATHERING WILL BE ALLOWED. No parties, birthday celebrations with invited guests and no religious and traditional services which entail the physical gathering of the people from two (2) or more households.

C. BARANGAY PARTICIPATION. Barangay Officials shall assist their constituents on procuring their basic necessities, Barangay Officials shall also be responsible for the strict enforcement of this order;

D. CURFEW AND LIQUOR BAN. Curfew hours and liquor ban shall be from 10:00 PM to 4:00 AM.

Section 3. Duration. This order shall be in effect for fourteen (14) days starting immediately upon signing.

Section 4. Penalties. All persons found violating the provisions of this order shall be subjected to administrative sanctions, without prejudice to prosecution of criminal action(s), if probable cause exists;

Section 5. Repealing Clause. All executive orders, proclamations, rules, regulations, previous issuances or parts thereof, inconsistent with the provisions of this Order are hereby repealed, amended and modified accordingly.

Section 6. Effectivity. This Executive Order shall take effect immediately.
