**EXECUTIVE ORDER NO. 037**  
**Series of 2021**

**AN ORDER LIFTING THE LOCKDOWN AND CONTAINMENT OF BARANGAY ELIZABETH, MARCOS, ILOCOS NORTE EXCEPT CERTAIN AREAS OF SITIO KARAGSAKAN (11 HOUSES AFFECTED), SITIO SADIRI (9 HOUSES AFFECTED), SITIO LIWLIWA (9 HOUSES AFFECTED) AND SITIO NAMNAMA (1 HOUSE AFFECTED).**

**WHEREAS**, the 1987 Constitution declared the policy of the State to protect and promote the right to health of the people and instill health consciousness among them;

**WHEREAS**, RA 11494 also known as the “Bayanihan to Recover as One Act” declared the policy of the State to mitigate the economic cost and losses stemming from the COVID-19 pandemic;

**WHEREAS**, due to the confirmed COVID-19 cases in Barangay Elizabeth, Marcos, Ilocos Norte Executive Order No. 34 series of 2021 was issued by the undersigned to facilitate contact tracing and to prevent the further spread of the COVID-19;

**WHEREAS**, Fifty Six (56) residents of Barangay Elizabeth were subjected to RT-PCR Test;

**WHEREAS**, the Fifty One (51) residents are negative and Five (5) residents are positive as per RT-PCR results issued in the afternoon of May 31, 2021;

**WHEREFORE**, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, **I, ANTONIO V. MARIANO**, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do order the following:

**SECTION 1. LIFTING THE LOCKDOWN AND CONTAINMENT OF BARANGAY ELIZABETH, MARCOS, ILOCOS NORTE EXCEPT CERTAIN AREAS OF SITIO KARAGSAKAN (11 HOUSES AFFECTED), SITIO SADIRI (9 HOUSES AFFECTED), SITIO LIWLIWA (9 HOUSES AFFECTED) AND SITIO NAMNAMA (1 HOUSE AFFECTED).** The Lockdown and Containment of Brgy. Elizabeth, Marcos, Ilocos Norte is hereby lifted except certain areas of Sitio Karagsakan (11 Houses Affected), Sitio Sadiri (9 Houses Affected), Sitio Liwliwa (9 Houses Affected) and Sitio Namnama (1 House affected). The said barangay shall immediately resume its usual operation except the above-mentioned Sitios.

**SECTION 2. REPEALING CLAUSE.** All executive orders, proclamations, rules, regulations, previous issuances or parts thereof, inconsistent with the provisions of this Order are hereby repealed, amended and modified accordingly.

**SECTION 3. EFFECTIVITY.** This Executive Order shall take effect immediately.
