**RECONSTITUTING THE LOCAL TRICYCLE TASK FORCE OF THE
MUNICIPALITY OF MARCOS, ILOCOS NORTE**

WHEREAS, under the Local Government Code, every local government unit shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare. Within their respective territorial jurisdiction;

WHEREAS, the Department of the Interior and Local Government (DILG) Memorandum Circular No. 2020-004 mandating the LGUs to regulate the operation of tricycles, and in the granting of franchises, reiterating further, specific provisions of RA 4136 (The Land Transportation and Traffic Code) on prohibition of illegal parking of motor vehicles in sidewalks;

WHEREAS, the Department of the Interior and Local Government (DILG) Memorandum Circular No. 2020-036 mandates the Local Government Unit to organized its Tricycle Task Force that shall primarily responsible for the crafting of Tricycle Route Plan which shall be basis for the crafting of local legislation relating to the regulation of tricycle, pedicabs and motorized pedicab operation within the jurisdiction of the LGU;

WHEREAS, there is a need to reconstitute the Local Tricycle Task Force to update its membership;

WHEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, **I, ANTONIO V. MARIANO**, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby create the Local Tricycle Task Force of the Municipality of Marcos, Ilocos Norte and order the following:

Section 1. Composition. The Local Tricycle Task Force shall be composed of the following:

Section 2. Duties and Functions. The Local Tricycle Task Force of the Municipality shall have the following functions:

1. Conduct meetings, public consultations and hearings with stakeholders, and survey/ocular inspection of the zone/area of tricycle operations with special focus on the following:
 - a. Rationalizing the authorized routes of all tricycles and pedicarbs to ensure that they are banned from national highways;
 - b. Identification of national roads within the area of jurisdiction of the LGU;
 - c. Determination of the portions of the national highway presently used or proposed to be traversed by tricycles only if there are no alternative routes available.

2. Draft or update the Tricycle Route Plan ("TRP")-within 30 days from the issuance of this memorandum, the committees shall come up with a TRP which shall be the basis of a subsequent ordinance.

Section 3. Repealing Clause. All executive orders, proclamations, rules, regulations, previous issuances or parts thereof, inconsistent with the provisions of this Order are hereby repealed, amended and modified accordingly.

Section 4. Effectivity. This Executive Order shall take effect immediately.
