

## **EXECUTIVE ORDER NO. 005** Series of 2021

RECONSTITUTING THE VALIDATION TEAM TO CERTIFY COMPLIANCE AND ACCOMPLISHMENT IN THE IMPLEMENTATION OF MEMORANDUM CIRCULAR NO. 2019-121 (ROAD CLEARING) OF THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG)

WHEREAS, Memorandum Circular No. 2019-121 was issued by the Department of the Interior and Local Government dated July 29, 2019 in line with the directive during the 4<sup>th</sup> State of the Nation Address of the President to clear roads of illegal structures and constructions;

WHEREAS, the same Memorandum Circular directs all local chief executives to revoke permits that give authority to private entities to occupy public roads, alleys and other thoroughfares;

WHEREAS, for strategic implementation of the Memorandum Circular, all provinces, highly urbanized cities (HUCs), cities and municipalities shall prepare an inventory of all roads within its jurisdiction and ensure immediate and effective implementation of road clearing operations;

WHEREAS, DILG Memorandum dated September 10, 2019 enjoins all Regional Directors, Provincial Directors, Cluster Officers and C/MLGOOs for the creation of Validation Teams to certify compliance and accomplishment of Local Government Units in the implementation of Memorandum Circular No. 2019-121 (Road Clearing);

WHEREAS, there is a need to reconstitute the Validation Team to update its membership and to replace members who no longer represent their office.

WHEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, I, ANTONIO V. MARIANO, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby reconstitute the Validation Team to Certify Compliance and Accomplishment in the Implementation of Memorandum Circular No. 2019 (Road Clearing) of the Department of the Interior and Local Government (DILG) and order the following:

Section 1. Composition. The Validation Team shall be composed of the following:

**Section 2.** Functions. The Validation Team shall have the following functions:

1. Discuss the status of implementing the said Memorandum Circular;


2. Profile the various obstructions identified based on the road inventory and report particularly the number and kind of obstructions in the municipality for the information and action of concerned Undersecretaries or Assistant Secretaries who have designated regional assignment/s;

3. Determine the actions undertaken and to be undertaken by the LGUs;

4. Provide assistance to the LGUs, particularly on the remaining activities to be undertaken, if any (i.e. road clearing, reclaiming roads and road rehabilitation).

5. To verify the actions taken by the LGUs, report utilizing the prescribed validation form, certified by the members of the team and accepted by the Municipal Mayor.

## **EXECUTIVE ORDER NO. 005** Series of 2021
