



**EXECUTIVE ORDER NO. 009**

**ESTABLISHMENT OF GRIEVANCE MECHANISM FOR THE IMPLEMENTATION OF THE ROAD CLEARING PROGRAM IN THE MUNICIPALITY OF MARCOS**

**WHEREAS**, Section 17 (b) of the Republic Act 7160 mandates the LGU's to maintain all local roads within their jurisdiction as a basic service and facility;

**WHEREAS**, DILG Memorandum Circular No. 2019-121, DILG Memorandum Circular No. 2019-167 and DILG Memorandum Circular No. 2020-027 enforces the Presidential Directive to clear all roads of illegal obstruction which among others provided guidelines for LGU's in the conduct of road clearing within their respective localities, with emphasis on implementation by Barangays and the clearing of the barangay and tertiary roads;

**WHEREAS**, as part of the road clearing process, the establishment of a grievance mechanism is deemed important to provide a measure of inquiry to protect the interest of those affected by the Road Clearing initiatives in the municipality;

**WHEREFORE**, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, **I, ANTONIO V. MARIANO**, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby order the following:

**Section 1. Establishment of Barangay Road Clearing Drop-box-** The Barangays of the Municipality of Marcos are required to put up a Barangay Road Clearing Drop-box in-front of their Barangay Halls which will serve as a point collection for grievances regarding the implementation of the Road Clearing program in their respective barangay. The Barangay Road Clearing Drop-box will be checked and forwarded to the Municipal Engineering Office every Friday for due action.

**Section 2. Establishment of an Electronic/ Social Media Grievance Mechanism-** The Official Facebook page of the Municipality of Marcos shall also serve as a transmission point for comments, queries and complaints regarding the implementation of the road clearing implementation in the municipality.

**Section 3. Information dissemination-** a copy of this Executive Order shall be distributed to all Barangays, concerned offices and also to be posted on the Official Facebook page of the Municipality.
