AMENDING SECTION 1-COMPOSITION OF EXECUTIVE ORDER NO. 023 SERIES OF 2020 OF THE MUNICIPAL PROJECT MONITORING COMMITTEE (PMC) OF THE LOCAL GOVERNMENT UNIT OF MARCOS, ILOCOS NORTE.

WHEREAS, Executive Order No. 376 s. 1989 as amended by Executive Order No. 93 s. 1993, mandates the creation of Project Monitoring Committee in the municipal level to facilitate project implementation and devolve facilitation, problem solving, monitoring and evaluation of foreign, national and locally funded projects;

WHEREAS, the Department of the Interior and Local Government (DILG) has issued Memorandum Circular No. 2004-78 dated June 22, 2004 enjoining the Local Government Units to organize, reactive or reconstitute the local PMC's in their respective areas of jurisdiction;

WHEREAS, the local Project Monitoring Committee is necessary for the monitoring, evaluation and formulation of recommendation on the implementation of development plans and programs in the municipality;

WHEREAS, there is need to amend the composition of the Municipal Project Monitoring Committee to replace **MR. JAIME GREGORY I. ESPINA**, MLGOO to avert paralization of the PMC activities and to effectively achieve the objectives of the committee;

WHEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, **I, ANTONIO V. MARIANO**, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby amend Section 1-Composition of Executive Order No. 023 series of 2020:

Section 2. FUNCTIONS. The Municipal Project Monitoring Committee shall have the following functions:

1. Prepare monitoring plans before end of current year as a basis for regular monitoring of succeeding year;
2. Schedule regular project field visits/inspections for a particular reporting period;
3. Conduct initial appraisal of projects to be monitored based on information from monitoring;
4. Coordinate/Establish linkage with project implementers to ensure timely submission of reports, accuracy of project evaluation and ensure their cooperation and active participation throughout the monitoring process;
5. Analyze project/activity accomplishment reports and project exception reports submitted;
6. Conduct regular ocular inspection and project sites;
7. Report findings and recommendation to Municipal Development Council or its ExCom for deliberations/resolutions/actions; and
8. Upon project completion, conduct post – evaluation of selected projects.

Section 3. REPEALING CLAUSE. All executive orders, proclamation, rules, regulations, previous issuances or parts thereof, inconsistent with the provisions of this Order are hereby repealed amended and modified accordingly.

Section 4. EFFECTIVITY. This Executive Order shall take effect immediately.
