

EXECUTIVE ORDER NO. 006 Series of 2022

AMENDING SECTION 3-BAC SECRETARIAT OF EXECUTIVE ORDER NO. 002 SERIES OF 2022 BIDS AND AWARDS COMMITTEE (BAC) OF THE LOCAL GOVERNMENT UNIT OF MARCOS, ILOCOS NORTE

WHEREAS, Republic Act 9184 otherwise known as Government Procurement Reform Act provides for the modernization, standardization and regulation of the procurement activities of the government. It also seeks to promote the basic principles of transparency, accountability, equity, effectiveness, efficiency and economy;

WHEREAS, the Local Government Unit of Marcos through the local chief executive signed Executive Order No. 002 series of 2022 dated January 11, 2022;

WHEREAS, the aforementioned executive order is pursuant to the implementing rules and regulations of Republic Act 9184 and to efficiently attain the primary concern of the government that procurement of goods, infrastructure project and consultancy services shall be competitive and transparent through public bidding;

WHEREAS, there is a need to amend the composition of BAC Secretariat of Executive Order No. 002 Series of 2022, to replace the Head of the BAC, MISS IEZEL AMOR REYES, due to other designations;

WHEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, I, ANTONIO V. MARIANO, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby order the following:

SECTION 1. AMENDMENT OF SECTION 3- BAC SECRETARIAT OF EXECUTIVE ORDER NO. 002 SERIES OF 2022. Section 3- BAC Secretariat series of 2022 is hereby amended, to replace the Head of the BAC, MISS IEZEL AMOR REYES, to read as follows:

"SECTION 3: THE BAC SECRETARIAT. MISS ROSEMARIE C. SABLOT, ADMINISTRATIVE AID VI IS HEREBY DESIGNATED AS HEAD OF THE BAC SECRETARIAT WITH MEMBERS AS FOLLOWS:

- 2. JIMMUEL B. ARZAGA, ADMINISTRATIVE OFFICER, COS

SECTION 2. EFFICACY OF THE PROVISIONS OF EXECUTIVE ORDER NO. 002 SERIES OF 2022. The provisions of Executive Order No. 002 series of 2022 as amended is hereby effective starting immediately upon signing.

SECTION 3. REPEALING CLAUSE. All executive orders, proclamations, rules, regulations, previous issuances or parts thereof, inconsistent with the provisions of this Order are hereby repealed, amended and modified accordingly.
