**AMENDING SECTION 1-COMPOSITION OF EXECUTIVE ORDER NO. 004  
SERIES OF 2022 OF THE MUNICIPAL PROJECT MONITORING COMMITTEE  
(PMC) OF THE LOCAL GOVERNMENT UNIT OF MARCOS, ILOCOS NORTE.**

**WHEREAS**, Executive Order No. 376 s. 1989 as amended by Executive Order No. 93 s. 1993, mandates the creation of Project Monitoring Committee in the municipal level to facilitate project implementation and devolve facilitation, problem solving, monitoring and evaluation of foreign, national and locally funded projects;

**WHEREAS**, the Department of the Interior and Local Government (DILG) Memorandum Circular No. 2004-78 dated June 22, 2004 enjoining the Local Government Units to organize, reactivate or reconstitute the local PMC's in their respective areas of jurisdiction;

**WHEREAS**, this Local Government Unit through the local chief executive signed Executive Order No. 004 Series of 2022 dated January 13, 2022 pursuant to the above-mentioned Executive Order No. 376 s. 1989 as amended by Executive Order No. 93 s. 1993 and Memorandum Circular No. 2004-78 issued by the DILG;

**WHEREAS**, there is a need to amend the composition of the Municipal Project Monitoring Committee due to the reorganization of chairman and members of the regular and standing committees of the Sangguninag Bayan of this municipality.

**NOW, THEREFORE**, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, **I, ANTONIO V. MARIANO**, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby order the following:

**SECTION 1. AMENDMENT OF SECTION 1-COMPOSITION OF EXECUTIVE ORDER NO. 004 SERIES OF 2022.** Section 1-Composition of Executive Order No. 004 Series of 2022 is hereby amended, to replace the VICE CHAIRPERSON, ELMER T MIGUEL, to read as follows:
