



EXECUTIVE ORDER NO. 012 Series of 2022

AN ORDER DIRECTING THE CREATION OF BARANGAY TASK FORCE FOR THE THIRTEEN (13) BARANGAYS OF MARCOS, ILOCOS NORTE IN SUPPORT TO END LOCAL COMMUNIST AND ARMED CONFLICT (ELCAC) AS EMBODIED IN EXECUTIVE ORDER NO.70 OF THE PRESIDENT OF THE PHILIPPINES

WHEREAS, the President of the Philippines, His Excellency Rodrigo Roa Duterte signed Executive Order No. 70 which aims to institutionalize the whole Nation Approach Policy in attaining inclusive and sustainable peace, creation and National Task Force to End Local Communist Armed Conflict (ELCAC) and directs for the formulation of a National Peace Framework, with the help of the National Agencies, Local Government Units, the civil society, and other stakeholders;

WHEREAS, pursuant to Section 16 of the Local Government Code of 1991 or the Republic Act 7160, which states that every local government unit shall exercise the powers expressly granted, those necessarily implied them from, as well as powers necessary, appropriate, or incidental for its efficient and effected governance, and those which are essential to the promotion of general welfare;

WHEREAS, with the aim to have a safe municipality, there is a need to create Barangay task force for the thirteen barangays of the municipality in support to end local communist and armed conflict and to adhere to the Municipality's goal for prosperity and peaceful community;

NOW, THEREFORE, premises considered and by the virtue of the powers vested in me under the laws of the Republic of the Philippines, I, ANTONIO V. MARIANO, Municipal Mayor of Marcos, Ilocos Norte, do hereby order the creation of Barangay Task Force for the thirteen barangays of the municipality in support to end local communist and armed conflict (ELCAC) as embodied in Executive Order No. 70 of the President of the Philippines and order the following:

SECTION 1. CREATION OF BARANGAY TASK FORCE, Directing all the Punong Barangays of the Thirteen (13) Barangays of Marcos, Ilocos Norte for the creation of Task Force which primary duty is to end local communist and armed conflict (ELCAC) – denouncing terrorism and all forms of lawlessness, violent extremism and intimidation which threatens order and safety and undermines and intimidation which threatens public order and safety and undermines stability and progress.

SECTION 2. REPEALING CLAUSE. All issuances, orders, rules and regulations, issued by the Municipality of Marcos that inconsistent with any provision of the Ordinance are hereby repealed and modified accordingly.

SECTION 3. EFFECTIVITY. This Order shall take effect immediately and shall remain effective until revoked or amended.
