SECTION 2. DUTIES AND FUNCTIONS OF THE MTTF-ELCAC OF MARCOS. In accordance with the guidelines embodied in DILG MC. NO. 2019-125 and NFT-ELCAC Joint Memorandum Circular No. 01, Series of 2019, and the MTF-ELCAC of Marcos shall perform the following duties and functions:

 Ensure the creation of the Barangay Task Force in the 13 Barangays of Marcos to complement EO 70 and this Executive order issued by the undersigned;

 Take the lead in the planning and implementation of the Retooled Community Support Program (RCSP)

Enlist the assistance of any department, bureau, office, agency, or instrumentality
of the government, the government-owned or controlled corporations (GOCCs),
and state universities and colleges (SUCs), in accordance with their respective
mandates, in coordination with the PTF, in the implementation of the RCSP;

 Facilitate the convergence of all stakeholders and ensure participation of the community members in development planning;

5. Adhere to the feedback mechanism prescribed by the Provincial Task Force and establish the same at the Municipal level down to the Barangay Level;

6. Ensure the delivery of services and inclusion of the policies, programs, projects, services and activities in the local plans based on the identified solutions by the members of the affected communities;

Strengthen and empower Barangay-Based Institutions (BBIs);

8. Establish and strengthen citizenship and community participation mechanisms

to guarantee sustainability of RCSP implementation;

9. Perform such other functions and duties as promulgated by the President, National/Provincial Task Force and Department of Interior and Local Government.

SECTION 3. DUTIES AND FUNCTIONS OF THE MUNICIPAL TASK FORCE SECRETARIAT. The MTF Secretariat shall perform the following duties and responsibilities:

> 1. Submit an organizational and staffing pattern and directory of the Municipal Task Force to the Provincial Task Force within one (1) month from the creation of Task Force;

Provide standard Secretariat services to the MTF;

3. Ensure proper coordination of the RCSP implementation through feedback mechanism established by the Provincial Task Force

SECTION 4. REPEALING CLAUSE. All Executive Orders that are inconsistent with this issuance are hereby repealed, amended or deemed modified accordingly;

SECTION 5. SEPARABILITY CAUSE. If in any provision of this Executive Order is declared invalid or unconstitutional, the other provisions not affected thereby shall remain valid in full force and effect.

SECTION 6. EFFECTIVITY. This Executive Order shall take effect immediately.

EXECUTIVE ORDER NO. 013 Series of 2022

CREATING THE MUNICIPAL TASK FORCE TO END LOCAL COMMUNIST ARMED CONFLICT (MTF-ELCAC) OF MARCOS, ILOCOS NORTE.

WHEREAS, Section 5, Article II of the 1987 Constitution states that, "The maintenance of peace and order, the protection of life, liberty and property and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracy,

WHEREAS, Section 16 of Republic Act no. 7160 otherwise known as Local Government Code expressly provides that "Every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which essential to promotion of the general welfare. Within their respective territorial jurisdictions, local government units shall ensure and support, among other things, the preservation and enrichment of culture, promote health and safety, enhance the right of the people to a balanced ecology, encourage and support development of appropriate and self-reliant scientific and technological capabilities, improve public morals, enhance economic prosperity and social justice, promote full employment among their residents, maintain peace and order and preserve the comfort and convenience of their inhabitants";

WHEREAS, Executive Order No. 70 Series of 2018 issued by President Rodrigo Roa-Duterte, institutionalized the "Whole of the Nation Approach" to attain inclusive and sustainable peace;

WHEREAS, the National Task Force to End Local Communist Armed Conflict (NFT-ECLAC) issued Joint Memorandum Circular No. 01 Series of 2019 to strengthen the operationalization of the Whole-of-the-nation Approach as part of the peace-building and conflict-resolution initiatives of the Government;

WHEREAS, DILG Memorandum Circular No. 2019-125 dated August 6, 2019 was issued providing Guidelines for local government units on the implementation of EO 70;

WHEREAS, pursuant to the above objectives, there is a need to create the Municipal Task Force to End Local Communist Armed Conflict (MTC-ELCAC);

NOW, THEREFORE, premises considered and by the virtue of the powers vested in me under the laws of the Republic of the Philippines, I, ANTONIO V. MARIANO, Municipal Mayor of Marcos, Ilocos Norte, do hereby order the creation of Municipal Task Force to end Local Communist Armed Conflict (MTF-ELCAC) of Marcos, Ilocos Norte with the following
