**Section 2. Functions.** The MDRRMC shall have the following functions pursuant to RA 10121.

1. Approve, monitor and evaluate the implementation of the Municipal DRRM Plan and regularly review, test and develop the plan consistent with other national and local planning programs;
2. Ensure the integration of disaster risk reduction and climate change adaptation into local development plans, programs and budgets as a strategy in sustainable development and poverty reduction;
3. Recommend the implementation of forces of pre-emptive evacuation of local residents, if necessary; and
4. Convene the local council once every three months or as necessary.

**Section 3. Secretariat.** The LDRRMO and the Office of the Municipal Social Welfare and Development shall serve as the secretariat of the Council.

**Section 4. Repealing Clause.** All executive orders, proclamations, rules, regulations, previous issuances or parts thereof, inconsistent with the provisions of this order are hereby repealed, amended and modified accordingly.

**RECONSTITUTING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL (MDRRMC) OF THE MUNICIPALITY OF MARCOS, ILOCOS NORTE**

**WHEREAS**, it is a declared policy of the state to uphold the people's constitutional rights of life and property by addressing the root causes of vulnerabilities to disaster, risk reduction and management and building the resilience of local communities to disaster, risk reduction and management building the resilience of local communities to disaster including climate change impacts,

**WHEREAS**, under Section 468 (a)(1)(iv) of the Local Government Code (RA 7160), it is the duty of the Municipal Government to adopt measures to protect the inhabitants of the municipality from, the harmful effects of man-made or natural disasters and calamities and to provide relief services and assistance for victims during and in the aftermath of said disaster and calamities;

**WHEREAS**, Sec. 11 of said law provides for the organization of the local government level of the Disaster Risk Reduction and Management Council and accordingly and existing Municipal Disaster Coordinating Council (MDCC) under PD 1566 shall hence forth be known as Municipal Disaster Risk Reduction and Management Council (MDRRMC);

**NOW THEREFORE**, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, I, **ANTONIO V. MARIANO**, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby reconstitute the Municipal Disaster Risk Reduction and Management Council (MDRRMC) and order the following:
