

Section 3. Duties and Functions. The Municipal Disaster Risk Reduction and Management Operation Center.

- 1. The Municipal Disaster Risk Reduction and Management Operation Center is a central command and control facility responsible for carrying out the principles of emergency preparedness and emergency management, or disaster management functions at a strategic level during an emergency, and ensuring the continuity of operation of the Municipality of Marcos, Ilocos Norte.
- 2. The Municipal Disaster Risk Reduction and Management Operation Center is responsible for the strategic overview, or "big picture", of the disaster, and does not normally directly control field assets, instead making operational decisions and leaving tactical decisions to lower commands. Primarily, the main functions of the Municipal Disaster Risk Reduction and Management Operation Center is to collect, gather and analyze data; make decisions that protect life and property, maintain continuity of the organization, within the scope of applicable laws; and disseminate those decisions to all concerned agencies and individuals.
- 3. The Municipal Disaster Risk Reduction and Management Operation Center will operate 24/7.


Section 4. Location of the Municipal Disaster Risk Reduction and Management Operation Center. The Municipal Disaster Risk Reduction and Management Operation Center shall be located at the Local Disaster Risk Reduction Management Office.

Section 5. Repealing Clause. All Executive Orders and other issuances or parts thereof inconsistent with this order are nearby repealed, modified or amended accordingly.

Section 6. Effectivity. This Executive Order shall take effect immediately. Done this 22nd day of MARCH, 2022 at Marcos, Ilocos Norte.

EXECUTIVE ORDER NO. 020 Series of 2022

AN ORDER ESTABLISHING THE MUNICIPAL DISASTER RISK REDUCTION AND MANAGEMENT OPERATION CENTER THAT WILL OPERATE 24/7 IN ORDER TO MANAGE ALL INCIDENTS NATURAL OR MAN-MADE THAT MIGHT AFFECT THE MUNICIPALITY OF MARCOS, ILOCOS NORTE.

WHEREAS, pursuant to RA 10121, the Municipal Disaster Risk Reduction and Management Council shall establish and Operating Facility on a 24/7 basis before, during and after calamity to be known as the Municipal Disaster Risk Reduction and Management Operation Center (MDRRMOC) of Marcos, Ilocos Norte,

WHEREAS, it is highly imperative to address incidents, adopt measures to reduce the risk and put in place an effective disaster risk reduction and management scheme in the municipality;

WHEREAS, with the aim of the Municipal Government to render effective response to incidentsO natural or man-made consistent with the provisions of RA 10121 otherwise known as the "Philippine Risk Reduction and Management Act of 2010", the Municipal Disaster Risk Reduction and Management Operation Center (MDRRMOC) of the municipality are composed of trained employees and volunteers that shall perform their duties before, during and after a disaster;

NOW THEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, I, ANTONIO V. MARIANO, Municipal Mayor of the Municipality of Marcos, do hereby establish the municipal disaster risk reduction and management operation center that will operate 24/7 in order to manage all incidents natural or man-made that might affect the municipality and order the following:

Section 1. Creation. There shall be a Municipal Disaster Risk Reduction and Management Operation Center in the Municipality of Marcos, Ilocos Norte referred as Municipal Disaster Risk Reduction and Management Operation Center.

The Municipal Disaster Risk Reduction and Management Operation Center shall be manned 24/7 by disaster response and rescue abled personnel and trained employees and volunteers.

Section 2. Composition. The Municipal Disaster Risk Reduction and Management Operation Center shall be composed with the following:
