




- h. Perform such other powers and functions necessary and proper in order to faithfully carry into effect the foregoing duties and functions and as may be assigned by the Local Chief Executive.

**Section 4. REPEALING CLAUSE.** All executive orders, proclamations, rules, regulations, previous issuance or parts thereof, inconsistent with the provisions of this order are hereby repealed, amended and modifies accordingly.

**Section 5. EFFECTIVITY.** This executive order shall take effect immediately.

EXECUTIVE ORDER NO. 025  
Series of 2022

**AN ORDER ESTABLISHING THE PERSONS WITH DISABILITY AFFAIRS OFFICE (PDAO), DESIGNATING THE PDAO FOCAL PERSON IN THE MUNICIPALITY OF MARCOS, ILOCOS NORTE.**

**WHEREAS**, Republic Act No. 7277, otherwise known as the “Magna Carta for Disabled Persons” direct national and local government agencies to implement programs and services to ensure full participation of person with disability in all aspects of community life;

**WHEREAS**, Section 2 (a) of the same Republic act states that disabled persons are part of the Philippine society, thus the Senate shall give full support to the improvement of the total well-being of disabled persons;

**WHEREAS**, in order to effectively sustain and continuously implement the provisions of the aforementioned Republic Act in the municipality, monitoring, evaluation, data gathering and creation of job opportunities and advocacy for persons with disability shall be administered;

**WHEREAS**, there is a need to establish a Person with Disability Affairs Office to serve as an arm of the local government unit in the implementation of the above-mentioned purposes;

**NOW THEREFORE**, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, I, **ANTONIO V. MARIANO**, Municipal Mayor of Marcos, Ilocos Norte, do hereby order establish the Persons with Disability Affairs Office in the Municipality of Marcos, Ilocos Norte and order the following:

**Section 1. Creation of Persons with Disability Affairs Office (PDAO).** There is hereby created Persons with Disability Affairs Office which shall be under the Office of the Mayor. The office of the PDAO shall be located at the Municipal Social Welfare and Development Office (MSWDO) or at such other place as may be determined by the Municipal Mayor.

**Section 2. Focal Person for Persons with Disability.** The Persons with Disability Affairs Office shall have a Focal Person designated by the Municipal Mayor and shall be under the latter’s direct control and supervision. The Focal Person shall handle the affairs and perform the functions of Persons with Disability Affairs Office. The Focal Person shall serve at such term at the pleasure of the Municipal Mayor.

**Section 3. Designation of Persons with Disability Focal Person.** Cynthia G. Ablog, Municipal Social Welfare and Development Officer is hereby designated as the Persons with Disability Affairs Office Focal Person and shall perform the following functions:

- a. Formulate and implement policies, plan and programs for the promotion of the welfare of PWDs in coordination with concerned national and local government agencies;
- b. Coordinate the implementation of the provisions of Republic Act 10070, Batas Pambansa Blg. 344, otherwise known as the Accessibility Law and other relevant laws at the local level;
- c. Represent PWDs in meeting of the local development councils and other special bodies;
- d. Recommend and enjoin the participation of Non-Government Organization (NGO’s) and People’s Organization (POs) in the implementation of all disability related laws and policies;
- e. Gather and compile relevant data on PWDs in their localities;
- f. Disseminate information including, but not limited to programs and activities for PWDs, including children with disability, and training and employment opportunities for PWDs;
- g. Submit reports to the office of the Local Chief Executive on the implementation of program and services for the promotion of the welfare of the PWDs;
