EXECUTIVE ORDER NO. 030 Series of 2022

CREATION OF THE MUNICIPAL TASK FORCE TO END LOCAL COMMUNIST ARMED CONFLICT (MTF-ELCAC) OPERATIONS CENTER OF THE LOCAL GOVERNMENT UNIT OF MARCOS, ILOCOS NORTE

WHEREAS, Executive Order No. 70 provides the institutionalization of the Whole-of-National Approach in attaining inclusive and sustainable peace, creation of the National Task Force to End Local Communist Armed Conflict, and directs for the formulation of the National Peace framework;

WHEREAS, the Whole-of-Nation approach addresses the root cause of insurgency, internal disturbances and tension, and other armed conflicts and threats by prioritizing and harmonizing the delivery of basic services and social and societal development packages by the government, facilitating and ensuring active participation of all sectors of the community in the pursuit of peace agenda.

WHEREAS, the National Peace Framework contains principles, plans, programs, and mechanisms to localize peace agreements and interventions that will bring inclusive and sustainable peace and address the root causes of insurgencies, internal disturbances, tension, and other armed conflicts threats in identified areas;

WHEREAS, the National Task Force to End Local Communist Armed Conflict (NTF-ELCAC) Memorandum Circular No. 20200617-001 sets forth the guidelines for the establishment and management of the NTF-ELCAC Operation Center (OPCEN) at the National Level down to the regional, provincial, city and municipal task forces nationwide, in order to have a systematic, efficient and centralized communications monitoring and report system.

WHEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, I, ANTONIO V. MARIANO, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby create the composition of the CITY/MUNICIPAL/BARANGAY TASK FORCE TO END LOCAL COMMUNIST ARMED CONFLICT (MTF-ELCAC) OPERATIONS CENTER and order the following:

SECTION 1. COMPOSITION. The MTF-ELCAC OPCEN shall be composed of the following:

Chief OPCEN : Hon. Antonio V. Mariano, Municipal Mayor

Assistant Chief: Pcpt. Jonevale T. Maramag, Chief of Police, Marcos MPS

Admin : Donna Bless A. Isaac, EnP., Municipal Planning and Development

Coordinator

Operation : Hon. Eugenio Navarro, SBM, Chairman, Committee on Peace,

Order & Safety

: Pssg. Dennis Ranga, ELCAC Focal Person, PNP

SECTION 2. DUTIES and FUNCTION. The MTF-ELCAC OPCEN shall operate 24/7 and be responsible for the consolidation and submission of the daily activity report, monthly, quarterly and annual accomplishment reports of the BTF-ELCAC to the PTF OPCEN.

The OPCEN members shall have the following duties and functions, to wit:

Chief

- 1. Responsible for the administrative and operational activities of the MTF-OPCEN;
- 2. Ensures the availability of reports for the information and composition of the National Task Force leadership; and
- 3. Perform other duties as directed.

Assistant Chief

- 1. Assistant to the OPCEN Chief in directing, supervising, and controlling the management of MTF-OPCEN;
- 2. Acts as Security Officer of the NTF-ELCAC OPCEN; and
- 3. Perform other duties as directed.

Admin Staff

- 1. Maintains files/records for incoming and outgoing communication;
- 2. Maintains and updates directory;
- 3. Facilitate the procurement of logistical requirements for the OPCEN; and
- 4. Perform other duties as directed.

Operation Staff

- 1. Renders 24/7 duty on a rotation basis;
- 2. Receives and transmits communication;
- 3. Makes follow-up of outgoing communication/directive/compliance with target dates;
- 4. Consolidated the daily, monthly, quarterly, and annual accomplishment reports of the BTF
- 5. Perform other duties as directed.

SECTION 3. LOCATION OF THE MTF-ELCAC OPCEN. The physical location of the MTF ELCAC shall be situated at Marcos MPS, Lydia, Marcos Ilocos Norte.

SECTION 4. EFFECTIVITY. This order shall take effect immediately.
