Section 2. FUNCTIONS. The Municipal Council for the Protection of children shall have the following functions:

- 1. Formulate plans, programs and policies for children that are gender fair, culturally relevant and responsive to the needs of diverse groups of children from 0-18 years old;
- 2. Prepare AWFP for children and recommended appropriations to the Sanggunian;
- 3. Provide coordinative linkages with other agencies and institutions in the planning, monitoring and evaluation of plans for children;
- 4. Provide technical assistance and financial support to the barangay council for the Protection of Children;
- 5. Establish and maintain database on children in the municipality;
- 6. Foster education for every child;
- 7. Advocate for the establishment and maintenance of playgrounds day care centers and other facilities necessary for child and youth development;
- 8. Recommend local legislations promoting child survival, protection, participation, and development with appropriate funding support;
- 9. Assist children in need of special protection and refer cases field against child abusers to proper agencies/institutions;
- 10. Conduct capability-building programs to enhance knowledge and skills in handling children's programs;
- 11. Document barangay best practices on children;
- 12. Monitor and evaluate the implementation of the program and submit quarterly status report to PCPC; and
- 13. Perform other functions as provided in the ECCD and other child related laws.

Section 3. REPEALING CLAUSE. All executive orders, rules and regulations and other Issuances or parts thereof inconsistent with this Executive Order is hereby repealed, amended, superseded or modified accordingly.

Section 4. **EFFECTIVITY**. This Order shall take effect immediately upon its approval.

REORGANIZING THE MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN (MCPC) OF THE MUNICIPALITY OF MARCOS, ILOCOS NORTE

WHEREAS, R.A. 7610 - SPECIAL PROTECTION OF CHILDREN AGAINST CHILD ABUSE, EXPLOITATION AND DISCRIMINATION ACT provides for stronger deterrence and special protection against child abuse, exploitation and discrimination and its corresponding penalties;

WHEREAS, Article 359 and 360 of the Civil Code of the Philippines stipulates that the "government shall establish Councils for the protection of Children";

WHEREAS, DILG Memorandum Circular No. 2002-121, dated August 5, 2002 provides Revised Guidelines on the organization and strengthening of the Local Councils for the Protection of Children (LCPC) incorporating thereat Early Childhood Care and Development (ECCD) Coordinating Committees at the Provincial City, Municipal and Barangay Levels;

WHEREAS, the Municipal Council for the Protection of Children needs to be reorganized to be fully harnessed as an efficient and effective advocate of the child's rights, and implementer of all children's programs in the municipality.

NOW THEREFORE, I, ANTONIO V. MARIANO, the Municipal Mayor of Marcos, Ilocos Norte, by virtue of the powers vested in me by law, do hereby order the reorganization of the Municipal Council for the Protection of Children of the Municipality of the Marcos, Ilocos Norte, to wit:
