2. Provide necessary technical assistance in the program implementation.
3. Coordinate the implementation/operationalization and sectoral activities at the municipal level to better executed the program objectives and functions.
4. Organize and strengthen inter-agency network to ensure convergence of services and produce actions as needed to improve program operations.
5. Prepare reports with issues and concerns and submit to the Regional Advisory committee.
6. Facilitate and address complaints, request of poor families concerned.
7. Help promote and disseminate the program to different stakeholders.
8. Provide for other logistic support but not limited to space and office paraphernalia for the municipal link for the period of program implementation.

Section 3. Repealing Clause. All executive orders, proclamations, rules, regulations, previous issuances or parts thereof, inconsistent with the provisions of this Order are hereby repealed amended and modified accordingly.

Section 4. Effectivity. This Executive Order shall take effect immediately.

RECONSTITUTING THE MUNICIPAL ADVISORY COMMITTEE (MAC) OF MARCOS, ILOCOS NORTE FOR THE PANTAWID PAMILYANG PILIPINO PROGRAM (4Ps) OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD)

WHEREAS, the Pantawid Pamilyang Pilipino Program (4Ps) is a program being implemented by the Department of Social Welfare and Development (DSWD) to address structural inequities in society and promote human capital development for the poor;

WHEREAS, the Department of Social Welfare and Development (DSWD) and the Local Government Unit has collaborate to strengthen the Pantawid Pamilyang Pilipino Program of the National Government;

WHEREAS, with the 4Ps being implemented by the Department of Social Welfare and Development, coordination with other government agencies, the local government unit and non-government organizations would be most beneficial and sustainable for the achievement of the objectives;

WHEREAS, there is a need to reconstitute the Municipal Advisory Committee to update its members;
