**Disposal and Engineering Team** Engr. Marielle Menor, All heavy equipment operators and Municipal Engineering Staff

**Section 3. Functions.** The following are the functions of the respective Teams:

**Rapid Action Team:** Carry out immediate diagnosis of suspected case and implement stumping out procedures as stated in the Approved National ASF contingency plan.

**Disease Investigation and Surveillance Team:** Conduct regular surveillance and profiling of swine diseases in identified priority areas and immediately conduct disease investigation on reported cases and coordinate with the Provincial Task Force.

**Quarantine Team:** Regulate movement of animals and conduct quarantine procedures during suspected and confirmed cases of African Swine Fever (ASF) as stated in the Approved National ASF contingency plan.

**Census Team:** Consolidate data on Swine population, farm location etc.

**IEC Team:** Ensure adequate public awareness of the general public on African Swine Fever (ASF) its disease status and implications.

**Disposal /Engineering Team:** Shall ensure availability of heavy equipment and drivers for a 24 hour duty and conduct proper disposal activities of afflicted hogs.

**Logistics:** Certifies the availability of funds, resources and other logistics needed especially during occurrence of such disease.

**Barangay Links:** Report any shipment or movement of live hogs, frozen meat and meat products and by products that are being sold in the barangay and coordinate with higher authorities for the proper zoning protocol and the manpower needed in maintaining checkpoints at quarantine and surveillance zones during whole duration of the disease control activity.

In general the Task force shall submit a consolidated report on all of the activities to the Office of the Mayor and/or as needs arises depending on the circumstances so that immediate and appropriate action shall immediately taken.

**Section 4. Installation of Checkpoints.** There shall be checkpoints installed in all possible entry points of delivery of swine/hogs outbound and inbound the municipality.

Zoning on the movement of animals shall be installed in infected barangays intended to control the spread of the virus and to protect other barangays with no cases.

**Section 5. Disease Investigation.** Disease investigation activity shall be done in accordance with the protocol set in Annex 2 Dept of Agriculture AO No. 07 series of 2021.

**Section 6. Disease Surveillance.** Surveillance activity shall be done in accordance with DA-AO No. 07 s. 2021.

**AN ORDER CREATING THE MUNICIPAL AFRICAN SWINE FEVER TASK FORCE (MASF-TF) AND PROVIDING MEASURES TO PREVENT THE SPREAD OF AFRICAN SWINE FEVER IN THE MUNICIPALITY OF MARCOS, ILOCOS NORTE**

**WHEREAS**, African Swine Fever (ASF) is a highly contagious haemorrhagic viral disease of domestic and wild pigs, which is responsible for serious economic and production losses in the affected areas within the country;

**WHEREAS**, President Rodrigo Duterte issued Administrative Order No. 22 series of 2020, directing all government agencies and local government units to strictly implement and comply with the National Zoning and Movement Plan for African Swine Fever (ASF);

**WHEREAS**, African Swine Fever (ASF) is highly contagious hemorrhagic viral disease of domestic and wild pigs which is responsible for serious economic loss of affected areas;

**WHEREAS**, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that every Local Government Unit shall exercise the powers expressly granted, those necessary implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance and those which are essential to the promotion of general welfare;

**WHEREAS**, Secretary William Dar issued Administrative Order No. 22, series of 2020, guidelines on Swine Depopulation after African Swine Fever (ASF) confirmation;

**WHEREAS**, African Swine Fever (ASF) virus has already afflicted several hogs in neighboring towns in Ilocos Norte;

**WHEREAS**, there is a need to create a task force to implement to execute curative and remedial measures on the adverse effects of the disease;

**NOW THEREFORE, I, ANTONIO V. MARIANO**, Municipal Mayor of the Local Government Unit of Marcos, Ilocos Norte, by virtue of the powers vested in me by law, do hereby order:

**Section 1. Composition.** – The African Swine Fever Task Force shall be composed of the following:

**Section 7.** Guidelines on the Depopulation after ASF Confirmation. Depopulation conducted after confirmed case of ASF in the municipality shall be in accordance with DA AO No. 22, Series of 2020.

**Section 8.** Awareness Campaign. Information education and awareness campaign shall be done to ensure all aspects relevant to ASF will be disseminated to all constituents.

**Section 9.** Incorporation Clause. Department of Agriculture, Administrative Order No. 7 s. of 2021 and other ASF issuances shall form and made integral part of this Executive Order.

**Section 10. Effectivity.** This Executive Order shall take effect immediately.
