

## EXECUTIVE ORDER NO. <u>050</u> Series of 2021

Section 2. Functions. The Municipal Technical Committee shall have the following Functions:

 Formulate and implement plans and programs consistent with the framework of RA 10068 otherwise known as "Organic Agriculture Act of 2010".

Coordinate and consolidate all efforts of different national government agencies (NGAs)
including its line agencies, local government units in the municipality and other stakeholders who
are mandated to implement and/or advocate organic agriculture.

Initiate intensive IEC in different levels comprehensively promoting the use and benefits
of organic agriculture.

Institute community organizing as program point of entry.

 Hold regular meeting at least once every month or special meeting when situation will require to discuss and deliberate pressing issues or problems affecting the implementation or organic agriculture program of the municipality.

 Establish linkage to other National Government Agencies, Non-Government Organization, People's Organization and the private sector in order to develop and promote organic farming in the municipality.

 Recommend other viable measures and strategies in developing and promoting organic farming.

 Formulate research and develop agenda for organic agriculture for long term plan reference.

 Perform other functions deemed necessary to assist the agricultural workers in their practice of agricultural farming.

Section 3. Repealing Clause. All executive orders, proclamations, rules, regulations, previous Issuances or parts thereof, inconsistent with the provisions of this Order are hereby repealed, amended and modified accordingly.

Section 4. Effectivity. This Executive Order shall take effect immediately.

## RECONSTITUTING THE MUNICIPAL TECHNICAL COMMITTEE ON ORGANIC AGRICULTURAL PROGRAM OF THE LOCAL GOVERNMENT UNIT OF MARCOS, ILOCOS NORTE

WHEREAS, it is a declared policy of the State to promote agriculture development, conserve environmental resources and promote social equity and product access to foreign and domestic markets of agriculture and fishery commodities;

WHEREAS, Executive Order 481 which is titled "Promotion and Development of Organic Agriculture in the Philippines," declares the government's policy to promote and develop organic agriculture in the country which includes all agricultural systems that promote environmentally, socially, and economically sound production of food and fibers;

WHEREAS, Section 14 of Republic Act 10068 otherwise known as the Organic Agriculture Act of 2010 provides among others that "every municipal mayor shall likewise, insofar as practicable, form a municipal technical committee for purposes of implementing activities in line with the National Organic Agricultural Program within each municipality;

WHEREAS, in promoting the agriculture sector of the municipality, it shall be in accord with the constitutional mandate that "the State shall protect and advance the right of the people to a balance and healthful ecology in consonance with the rhythm and harmony of nature"

WHEREAS, the reorganization of the Municipal Technical Committee on organic agricultural program is vital to the success of the municipality in its desire to advocate, develop and promote organic farming and to update its membership.

WHEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, I, ANTONIO V. MARIANO, Municipal Mayor of the Municipality of Marcos Ilocos Norte, do hereby reconstitute the Municipal Technical Committee on Organic Agricultural Program of the Local Government Unit of Marcos, Ilocos Norte and order the following:

Section 1. Composition. The Municipal Technical Committee on Organic Agricultural Program shall be composed of the following:
