

EXECUTIVE ORDER NO. <u>056</u> Series of 2021

C.BARANGAY PARTICIPATION. Barangay Officials shall assist their constituents on procuring their basic necessities, Barangay Officials shall also be responsible for the strict enforcement of this order.

Section 3. Duration. This order shall be in effect for fourteen (14) days starting immediately upon signing.

Section 4.Penalties. All persons found violating the provisions of this order shall be subjected to administrative sanctions, without prejudice to prosecution of criminal action(s), if probable cause exists.

Section 5. Repealing Clause. All executive orders, proclamations, rules, regulations, previous issuances or parts thereof, inconsistent with the provisions of this Order are hereby repealed, amended and modified accordingly.

Section 6.Effectivity. This Executive Order shall take effect immediately.

AN ORDER DECLARING LOCKDOWN AND CONTAINMENT OF BARANGAY FORTUNA, MARCOS, ILOCOS NORTE. (EXCEPT SITIO CAPPIA)

WHEREAS, Section 16 of the Local Government Code of 1991 mandates the Local Government Units to, among others promote the health and safety of their constituents;

WHEREAS, President Rodrigo Roa Duterte through Proclamation No. 922 s. 2020, declared a state of public health emergency due to the rapid proliferation of COVID-19 in the country;

WHEREAS, Section 2 of Executive Order No. 112 authorized Mayors to impose lockdown of Barangays or part thereof, within their territorial jurisdiction;

WHEREAS, there is a need to impose lockdown and containment of the said Barangay to facilitate contact tracing purposes and for the abatement of further transmission;

WHEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, I, ANTONIO V. MARIANO, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby order the following:

Section 1. Declaration of Lockdown and Containment to the following:

BARANGAY FORTUNA: ENTIRE BARANGAY EXCEPT SITIO CAPPIA

Section 2. Policy Guidelines. Pursuant to the declaration of Lockdown and Containment to Barangay Fortuna, the residents of the said barangay ordered and directed to obey, follow and abide strictly to the following policies and guidelines:

A. MANDATORY HOME QUARANTINE. All residents of the affected barangay during the effectivity of this order shall stay at home and movement outside their home shall allowed only for purposes of accessing basic necessities. Provide that only one member of the household is allowed to go out for this purpose except:

- Those which require medical attention and one companion such as patients undergoing dialysis, cancer patients and other emergency patients are allowed to attend to their medical necessities;
- Health workers residing in the said areas except identified contact;
- Officers of the PNP,AFP and other government workers rendering emergency frontline service except identified contact;
- Service workers who are working in pharmacies, drug stores and death care services except identified contact;

B. COMPLETELY NO MASS GATHERING WILL BE ALLOWED. No parties, birthday celebrations with invited guests and no religious and traditional services which entail the physical gathering of the people from two (2) or more households.
