

## **EXECUTIVE ORDER NO. 058** Series of 2021

- Mandatory use of facemask and faceshield;
- b. Observe physical distancing of a minimum distance of two (2) meters or roughly six (6) feet from one another,
- Observe proper hygiene such as but not limited to proper sanitizing and handwashing.

All persons found violating the provisions of this order shall be subjected to administrative sanctions, without prejudice to prosecution of criminal action(s), if probable cause exists;

Section 5. Enforcement. The Marcos Municipal Police Station and other duly delegated local enforcers are hereby mandated to ensure the compliance to the full extent and strict implementation of this order.

Section 5. Repealing Clause. All executive orders, proclamations, rules, regulations, previous issuances or parts thereof, inconsistent with the provisions of this Order are hereby repealed, amended and modified accordingly.

Section 6. Effectivity. This Executive Order shall take effect immediately.

EXECUTIVE ORDER NO. 058 Series of 2021

AN ORDER DECLARING LOCKDOWN AND CONTAINMENT TO ALL OFFICES OF THE LOCAL GOVERNMENT UNIT LOCATED AT BARANGAY LYDIA, MARCOS, ILOCOS NORTE.

WHEREAS, Section 16 of the Local Government Code of 1991 mandates the Local Government Units to, among others promote the health and safety of their constituents;

WHEREAS, President Rodrigo Roa Duterte through Proclamation No. 922 s. 2020, declared a state of public health emergency due to the rapid proliferation of COVID-19 in the country;

WHEREAS, Section 2 of Executive Order No. 112 authorized Mayors to impose lockdown of Barangays or part thereof, within their territorial jurisdiction;

WHEREAS, employees of the LGU reported positive to COVID-19;

WHEREAS, there is a need to impose lockdown and containment of all offices of this municipality located at Brgy. Lydia to focus efforts on preventing the transmission of the virus, decontamination and swab testing (RT-PCR) of the employees;

WHEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, I, ANTONIO V. MARIANO, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby order the following:

Section 1. Declaration of Lockdown and Containment. All offices of the Local Government Unit shall be temporarily closed starting immediately until further notice to facilitate disinfection/decontamination.

All employees shall adopt the Alternative Work Arrangement (Work From Home) except the Municipal Health Office and LDRRMO.

Market and Slaughterhouse shall operate on a fifty (50%) percent workforce and their respective personnel scheduled to report to duty on a rotational basis.

All offices of the LGU may resume its normal operations until the release of the negative swabtest results of all employees who had undergone RT-PCR swab testing and if there will be no new case/s that will emerge from the roster of personnel who underwent swab-testing either as surveillance or as primary contacts;

Section 2. Strict Stay at Home Order. All identified high risk primary contacts shall undertake the mandatory quarantine period for (14) days even if their result is negative;

Section 3. Observance of Health Protocols. Upon resumption of operations, all employees and all persons/individuals going to all offices of the LGU shall strictly observe minimum health protocols at all times.
