AN ORDER AMENDING EXECUTIVE ORDER NO. 056 SERIES OF 2021 TO INCLUDE SITIO CAPPIA OF BRGY. FORTUNA UNDER LOCKDOWN AND CONTAINMENT.

WHEREAS, Section 16 of the Local Government Code of 1991 mandates the Local Government Units to, among others promote the health and safety of their constituents;

WHEREAS, President Rodrigo Roa Duterte through Proclamation No. 922 s. 2020, declared a state of public health emergency due to the rapid proliferation of COVID-19 in the country;

WHEREAS, Section 2 of Executive Order No. 112 authorized Mayors to impose lockdown of Barangays or part thereof, within their territorial jurisdiction;

WHEREAS, on July 26, 2021, the municipality of Marcos issued Executive Order No. 056 entitled, An Order Declaring Lockdown and Containment of Brgy. Fortuna, Marcos, Ilocos Norte except Sitio Cappia;

WHEREAS, a resident of Sitio Cappia reported as the positive COVID-19 Case;

WHEREAS, there is a need to impose lockdown and containment of the said Sitio to facilitate contact tracing purposes and for the abatement of further transmission;

WHEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, **I, ANTONIO V. MARIANO**, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby order the following:

Section 1: AMENDMENT OF EXECUTIVE ORDER NO. 056 SERIES OF 2021 TO INCLUDE SITIO CAPPIA OF BRGY. FORTUNA UNDER LOCKDOWN AND CONTAINMENT. Section 1 of EO No. 056 series of 2021 is hereby amended, to include the Sitio Cappia, to read as follows:

“SECTION 1: Declaration of Lockdown and Containment to entire Barangay Fortuna, Marcos. The entire Barangay Fortuna is hereby indefinitely placed under lockdown and containment. “

Section 2. Efficacy of the provisions of EO No. 056 series of 2021. The provision of EO No. 056 series of 2021 as amended is hereby effective for fourteen (14) days starting immediately upon signing.
