



**EXECUTIVE ORDER NO. 071**  
Series of 2021

**AN ORDER LIFTING THE LOCKDOWN AND CONTAINMENT OF SITIO MANGNGATO (EXCEPT 3 HOUSEHOLDS), SITIO IMEE (EXCEPT 1 HOUSEHOLD), AND SITIO CANIOGAN (EXCEPT 1 HOUSEHOLD) OF BARANGAY IMELDA, MARCOS, ILOCOS NORTE.**

**WHEREAS**, Section 16 of the Local Government Code of 1991 mandates the Local Government Units to, among others promote the health and safety of their constituents;

**WHEREAS**, President Rodrigo Roa Duterte through Proclamation No. 922 s. 2020, declared a state of public health emergency due to the rapid proliferation of COVID-19 in the country;

**WHEREAS**, Section 2 of Executive Order No. 112 authorized Mayors to impose lockdown of Barangays or part thereof, within their territorial jurisdiction;

**WHEREAS**, in view of the confirmed positive cases of COVID-19 from Barangay Imelda, Executive Order No. 69 series of 2021 was issued by the undersigned to focus efforts on preventing the transmission of the virus;

**WHEREAS**, the COVID-19 Task Force, Municipal Health Office with the assistance of the Department of Health, Barangay Officials, PNP and all others concerned have concluded the contact tracing;

**WHEREFORE**, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, **I, ANTONIO V. MARIANO**, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby order the following:

**Section 1. LIFTING THE LOCKDOWN AND CONTAINMENT OF SITIO MANGNGATO (EXCEPT 3 HOUSEHOLDS), SITIO IMEE (EXCEPT 1 HOUSEHOLD) AND SITIO CANIOGAN (EXCEPT 1 HOUSEHOLD) OF BARANGAY IMELDA, MARCOS, ILOCOS NORTE.** The lockdown and containment of Sitio Mangngato (Except 3 Households), Sitio Imee (Except 1 Household), and Sitio Caniogan (Except 1 Household) of Barangay Imelda, Marcos, Ilocos Norte is hereby lifted.

**Section 2. REPEALING CLAUSE.** All executive orders, proclamations, rules, regulations, previous issuances or parts thereof, inconsistent with the provisions of this Order are hereby repealed, amended and modified accordingly.

**Section 3. EFFECTIVITY.** This Executive Order shall take effect immediately.
