## EXECUTIVE ORDER NO. 074 Series of 2021

## "AN ORDER CREATING THE LOCAL PUBLIC TRANSPORT ROUTE PLAN (LPTRP) TEAM OF THE MUNICIPALITY OF MARCOS, ILOCOS NORTE AND DEFINING ITS COMPOSITION, FUNCTIONS, DUTIES AND RESPONSIBILITIES."

WHEREAS, Section 17 (a) of Republic Act 7160, otherwise known as "The Local Government Code of 1991", provides that Local Government Units shall discharge the functions and responsibilities of national agencies and offices devolved to them pursuant to this Code. Local government units shall likewise exercise such other powers and discharge such other functions and responsibilities as are necessary, appropriate, or incidental to efficient and effective provisions of the basic services and facilities;

WHEREAS, pursuant to Department Order No. 2017-011 dated 19 June 2017 form the Department of Transportation (DOTr) entitled the "Omnibus Guidelines on the Planning and Identification of Public Road Transportation Services and Franchise Issuance". the municipal government shall have the responsibility or formulating the Local Public Transport Route Plans (LPTRPs) for intra-municipality trips of public utility vehicles and the of collecting data, analyzing public transport supply and demand and identify specific public transport supply gaps for travel territories and for capturing this in city and municipality public transportation plans;

WHEREAS, Section 4 (c) (i) of Joint Memorandum Circular No. 001 Series of 2017 dated 19 June 2017 from the Department of the Interior and Local Government (DILG) and the Department of Transportation (DOTr) provides that LGUs shall constitute an LPTRP Team that will focus on the formulation of the LPTRP;

WHEREAS, DILG Memo. Circular No. 2018-60 dated May 03, 2018, mandates Local Chief Executives to mobilize a LPTRP Team composed of competent personnel from planning and development, engineering & traffic management who shall be responsible for the preparation of the LPTRP;

NOW THEREFORE, I, ANTONIO V. MARIANO, Municipal Mayor of Marcos, Ilocos Norte, by virtue of the powers vested in me by law, hereby order the following:

SECTION 1. CREATION. There is hereby created a LOCAL PUBLIC TRANSPORT ROUTE PLAN TEAM in the Municipality of Marcos, Ilocos Norte that will focus on the formulation of the Local Public Transport Route Plan of the Municipality.

SECTION 2. COMPOSITION. The Local Public Transport Route Plan Team shall be composed of the following:

SECTION 3. FUNCTIONS, DUTIES AND RESPONSIBILITIES. The Local Public Transport Route Plan Team shall have the following functions, duties and responsibilities:

- Formulate, prepare and submit the Local Public Transport Route Plan of the Municipality of Marcos to LTFRB for compliance with the concurrence and approval of the Sangguniang Bayan.
- Determine the appropriate public transportation routes within the Municipality based on the passenger demand and corresponding public transport services.
- 3. Review the existing transportation plan and aligned it to the provisions of the Omnibus Guidelines on the Planning and Identification of Public Road Transportation Services and Franchise Issuance and complement other transportation modes such as non-motorized transport (NMT), rail, maritime, and civil aviation.
- Identify and recommend New or Developmental Routes, new road facilities, and possible amendments to existing transport code of the municipality.
- Undertake the collection of relevant data and conduct surveys necessary for the LPTRP and conduct surveys necessary for the LPTRP and conduct consultation to stakeholders.
- Conduct monitoring and evaluation of the approved and compliant LPTRP within six (6) months
  after its full implementation and report back to LTFRB any modification or amendment necessary
  to improve the transportation route in the Municipality.

SECTION 4. REPEALING CLAUSE. All municipal executive orders, rules and regulations, inconsistent herewith are repealed, amended and modified according.

SECTION 5. SEPARABILITY CLAUSE, if for any reason, any section or provision of this Executive Order is declared to be unconstitutional or invalid by any competent court the other section or provision hereof which are not affected thereby shall continue to be in full force and effect.

Section 6. EFFECTIVITY. This executive order shall take effect immediately.
