



EXECUTIVE ORDER NO. 035

AMENDING THE COMPOSITION OF THE LOCAL SCHOOL BOARD (LSB) OF THE MUNICIPALITY OF MARCOS, ILOCOS NORTE

WHEREAS, Section 1 of Article XIV of the Philippine Constitution mandates the state to uphold the protection and promotion of the rights of all citizens to quality education at all levels and take appropriate steps to make such education accessible to all;

WHEREAS, Section 98 of the Local Government Code of 1991 provides for the mandatory creation of a Local School Board in every Local Government Unit;

WHEREAS, the Local School Board is tasked to determine the supplementary budgetary needs for the operation and maintenance of public schools;

WHEREAS, this will strengthen the function and supervision of the Local School Board;

WHEREAS, there is a need to amend the composition of the LSB due to the reorganization of the regular or standing committee due to the 2022 National and Local Elections and to replace members who no longer represent their office;

WHEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, **I, ANTONIO V. MARIANO**, Municipal Mayor of the Municipality of Marcos, Ilocos Norte, do hereby amend the composition of Local School Board of Marcos, Ilocos Norte and order the following:

Section 1. Composition. The Local School Board (LSB) shall be composed of the following:

Section 2. Functions. The LSB shall have the following functions:

1. Determine, in accordance with the criteria set by the Department of Education, the annual supplementary budgetary needs for the operation and maintenance of public schools within the municipality, and the supplementary cost of meeting





such as needs which shall be reflected in the form of an annual school board budget corresponding to its share of the proceeds of the special levy on Real Property constituting the Special Education Fund (SEF) and such other sources of revenues as the Code and other laws or ordinances may provide;

2. Authorize the Municipal Treasurer to disburse funds from the SEF pursuant to the budget prepared and in accordance with existing rules and regulations;
3. Serve as an advisory committee to the Sangguniang Bayan on educational matters such as, but not limited to the necessity for and the uses of local appropriations for educational purposes;
4. Recommend changes in the names of public schools within the territorial jurisdiction of the municipality for enactment by the Sangguniang Bayan.

Section 4. Repealing Clause. All executive orders, proclamations, rules, regulations, previous issuances, or parts thereof, inconsistent with the provisions of this Order are hereby repealed, amended, and modified accordingly.

Section 5. Effectivity. This Executive Order shall take effect immediately.
