EXECUTIVE ORDER NO. 036 Series of 2022

AMENDING SECTION 1 OF THE LOCAL HEALTH BOARD (LHB) OF THE LOCAL GOVERNMENT UNIT OF MARCOS, ILOCOS NORTE

WHEREAS, Section 102 of R.A., otherwise known as the Local Government Code of 1991, mandates all local government units to organize a Local Health Board;

WHEREAS, Section 16 of the same Code provides that the local government units shall promote and ensure the health and safety of its inhabitants;

WHEREAS, Section 17 of the LGC of 1991 provides the LGU's basic health services, which include the implementation of programs and projects on primary health care, maternal and child care, and communicable and non-communicable disease control services; access to secondary and tertiary health services; purchase of medicines, medical supplies, and equipment needed to carry out the health services;

WHEREAS, there is a need to amend the Local Health Board of the Local Government Unit of Marcos to replace members who no longer represent their office.

WHEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, **I, ANTONIO V. MARIANO,** Municipal Mayor Marcos, Ilocos Norte, hereby amend Section 1 of the Local Health Board and order the following:

Section 1. Composition. The Local Health Board shall be composed of the following:

Section 2. Functions. The Local Health Board shall perform the following:

1. To propose to the Sanggunian, in accordance with the standards and criteria set by the Department of Health, annual budgetary allocations for the operations and maintenance of health services within the municipality.

2. To serve as an advisory committee to the Sanggunian on health matters such as, but not limited to, the necessity for and application of local appropriation for public health

purposes: and

3. Consistent with the technical and administrative standards of DOH, create committees that shall advise local health agencies on matters such as, but not limited to, personnel selection and promotion, bids and awards, grievances and complaints, personnel discipline, and budget review. Operations review and similar functions.

Section 3. Repealing Clause. All executive orders, proclamations, rules, regulations, previous issuances, or parts thereof inconsistent with the provisions of this Order are hereby repealed, amended, and modified accordingly.

Section 4. Effectivity. This Executive Order shall take effect immediately.
