EXECUTIVE ORDER NO. 005 Series of 2023

RECONSTITUTING THE MUNICIPAL PEACE AND ORDER COUNCIL (MPO GOVERNMENT UNIT OF MARCOS, ILOCOS NORTE, AND CREATING ITS SECRETARIAT AND TECHNICAL WORKING GROUP FOR THE PEACE AND ORDER AND PUBLIC SAFETY (POPS) PLAN

WHEREAS, Section 116 of Republic Act 7160, otherwise known as the Local Government Code of 1991, mandates the establishment in every province, city, and municipality of a Local Peace and Order Council pursuant to Executive Order No. 309, Series of 1988;

WHEREAS, Executive Order No. 773, Series of 2009, further recognized the Peace and Order Councils of which the membership at the National, Regional and Local levels expanded;

WHEREAS, one of the functions of the Regional, Provincial, City, and Municipal Peace and Order Councils, as provided in the DILG Memorandum Circular No. 2015-130 dated November 3, 2015, is the formulation of a three-year Local Peace and Order and Public Safety (POPS) Plan;

WHEREAS, the same Memorandum Circular provides for the creation of a Technical Working Group (TWG) of the Municipal Peace and Order Council (MPOC) for POPS Planning following the guidelines prescribed by the DILG on the tools and processes;

WHEREAS, there is a need to reconstitute the Municipal Peace and Order Council of the Municipality of Marcos to update its membership as a result of the May 2022 Elections and to replace members who no longer represent their office and a need to create its Secretariat to assist the MPOC in the conduct of Council activities and the MPOC-TWG to carry out the POPS Planning effectively;

WHEREFORE, premises considered and by virtue of the powers vested in me under the laws of the Republic of the Philippines, I, RHONEL ALLAN M. COLOMA, Acting Municipal Mayor of Marcos, Ilocos Norte, do hereby order the following:

Section 1. Reconstitution of the Municipal Peace and Order Council (MPOC) of Marcos, Ilocos Norte. The Municipal Peace and Order Council shall be composed of the following:

Section 2. Functions. The Municipal Peace and Order Council shall perform the following functions:

- 1. Pass a resolution on the membership of the MPOC during the 1st quarterly meeting;
- 2. Convene quarterly meetings or as often as the need arises;
- Formulate a 3-year Local Peace and Order and Public Safety Plan (POPS) Plan, to be incorporated/and consistent with the Comprehensive Development Plan (CDP);
- 4. Provide a forum for interdisciplinary dialogue and deliberation of major issues and concerns affecting peace and order and public safety nationwide;
- Recommend strategic actions or activities aimed at promoting, improving, or enhancing peace and order and public safety measures, including anti-insurgency measures within their respective areas of jurisdictions;
- Recommend measures to converge and orchestrate internal security operations efforts of civil authorities and agencies, military, and police;
- Formulate and adopt an effective mechanism for the coordination, cooperation, and consultation involving the local executives, citizenry, and law enforcement agencies under R.A. 6975, as amended, in the adoption of the Community and Service-Oriented Policing (CSOP) System;
- Apply moral suasion to and recommend sanctions against local chief executives who are giving material and political support to the insurgents;
- Monitor the provision of livelihood and infrastructure development programs and projects in remote rural and indigenous population areas to isolate them from the insurgents' ideological, political, and organizational works.

Section 4. Functions of the MPOC Secretariat. The MPOC Secretariat shall perform the following functions:

- 1. Assist the Chairperson in the conduct of MPOC meetings;
- Provide technical assistance in the performance of administrative and technical tasks of the MPOC;
- Recommend and prepare MPOC agenda and other similar documents during Council meetings;
- 4. Prepare resolutions of the Council and the minutes of the meeting;
- 5. Prepare and submit Reports;
- 6. Prepare and submit quarterly MPOC Secretariat Accomplishment Reports;
- Provide technical support and assistance to activities related to E-CLIP, PAMANA, Regional Task Forces, and other programs concerned with peace and order and public safety of the municipality; and
- 8. Perform such other tasks as may be directed by the Council.

Section 5. Creation of the MPOC Technical Working Group (TWG) for the Peace and Order and Public Safety (POPS) Plan. The MPOC - TWG for POPS Plan shall be composed of the following:

Section 6. Functions of the MPOC-TWG. The MPOC-TWG shall perform the following functions:

- 1. Present data to the MPOC for prioritization of issues and development of strategies;
- Conduct data gathering and stakeholder consultations as needed and analyze data gathered;
- Coordinate with communities or barangays for data-gathering and action planning for the implementation of the POPS Plan;
- 4. Lead in the formulation of the POPS Plan;
- Prepare documents that could serve as a reference for the profiling of the strategic direction and peace and order and public safety issues in the locality;
- 6. Draft and finalize the POPS Plan;
- In coordination with the Mayor, convene the MPOC and present the POPS Plan for discussion, approval, and appropriate action;
- 8. Take part in the submission and adoption of the POPS Plan;
- 9. Encode the approved POPS Plan;
- Coordinate with internal and external stakeholders for effective communication and monitoring as laid out in the POPS Plan;

- 11. Ensure inclusion of key programs or strategies such as Community and Service-Oriented Policing (CSOP) and conflict-sensitivity, if deemed appropriate, in the POPS Plan; and
- 12. Regularly submit POPS Plan accomplishment report to the MPOC Secretariat.

Section 7. Repealing Clause. All executive orders, proclamations, rules, regulations, previous issuances, or parts thereof inconsistent with the provisions of this Order are hereby repealed, amended, and modified accordingly.

Section 8. Effectivity. This Executive Order shall take effect immediately.
