3. Sealed bids must be duly received by the Disposal Committee Secretariat through manual submission at the Municipal Conference Hall, 2nd Floor on March 23, 2023 not later than 1:00 PM. Bid Opening will be at 2:00 PM in same venue.

4. No bid shall be considered unless accompanied by ten percent (10%) of the Appraised Value bid bond in the form of cash or cashier's/manager's check payable to the Municipality of Marcos. Personal checks are not accepted.

5.Late bids are not accepted. Bid will be opened in the presence of all bidders or their duly authorized representatives, COA representative and observers. Abstract of bids shall be prepared wherein the highest responsive bid offered shall be the winning bid provided that the bid amount is higher than the Appraised Value. Winning Bidder shall pay the bid bond to the Municipal Treasury Office after award. The bid bond of the non-winning bidders shall be returned outright after the issuance of Notice of Award (NOA) to the winning bidder.

6.After payment of the awarded item, the awardee shall withdraw the item awarded. Otherwise, the awardee shall pay a corresponding storage fee equivalent to one-tenth of one percent of the price of the unwithdrawn item or P200/day of delay whichever is higher but not to exceed ten percent (10%) of the total amount of the award.


7.In case of partial payment, the ten percent (10%) Bid Bond shall be forfeited if the full price is not paid within five (5) days upon receipt of the NOA by the winning bidder and the Municipality of Marcos may rescind/ cancel the award and impose appropriate sanctions and penalty.

8.Actual release/withdrawal of awarded item/items shall be made within three (3) weeks, 9:00am to 4am Monday to Friday and shall be witnessed by the designated representatives of the Disposal Committee, Commission On Audit and Observers who shall affix their signatures on the "Release Order".

9. Interested bidders may obtain further information from *Municipality of Marcos Ilocos Norte* and may avail Bid Tender Form at the address given below **starting April 24, 2023**.


10.The *Municipality of Marcos Ilocos Norte Disposal Committee* reserves the right to reject any or, or any part thereof, waives any formality, requirements or defects contained therein without any obligation to explain the reasons thereof and will accept the offer it considers most advantageous to the government.
