4. Sealed bids must be duly received by the Disposal Committee Secretariat through manual submission at the Municipal Conference Hall, 2nd Floor on June 9, 2023 not later than 1:00PM. Bid Opening will be at 2:00 PM, same time and same venue.

5. No bid shall be considered unless accompanied by ten percent (10%) of the Appraised Value bid bond in the form of cash or cashier's/manager's check. Personal checks are not accepted.

6. Late bids are not accepted. Bid will be opened in the presence of all bidders or their duly authorized representatives. Abstract of bids shall be prepared wherein the highest responsive bid offered shall be

the winning bid provided that the bid amount is higher than the Appraised Value. Winning Bidder shall pay the bid bond to the Municipal Treasury Office after award. The bid bond of the non-winning bidders shall be returned outright after the issuance of Notice of Award (NOA) to the winning bidder.

7.The ten percent (10%) Bid Bond shall be forfeited if the full price is not paid within five (5) days upon receipt of the NOA by the winning bidder.

8.Interested bidders may obtain further information from *Municipality of Marcos Ilocos Norte* and may avail of Bidding Documents upon payment of non-refundable application fee in the amount of Two Hundred Pesos (Php200.00) at the address given below starting **June 2 to June 8, 2023 at 9:00 a.m to 4:00 p.m at the Municipal Budget Office.**
