EXECUTIVE ORDER NO. 023 Series of 2023

RECONSTITUTING THE MUNICIPAL PERFORMANCE ASSESSMENT TEAM (MPAT) FOR THE CY 2023 IMPLEMENTATION OF THE SEAL OF GOOD LOCAL GOVERNANCE FOR BARANGAY (SGLGB)

**WHEREAS,** Section 5, Article II of the 1987 Constitution of the Republic of the Philippines declares that the maintenance of peace and order, the protection of life, liberty, and prosperity, and the promotion of the general welfare are essential for the enjoyment by all the people of the blessings of democracry;

WHEREAS, Section 32 of the LGC of 1991 provides for the city and municipal supervision over their respective barangays. Through the city or municipal mayor concerned, they shall exercise genereral supervision over component barangays to ensure that said barangays act within the scope of their prescribed powers and functions;

**WHEREAS,** Section 17(b) (2) of Republic Act No. 7160, declares the provision of the minimum basic services and facilities in the barangay;

WHEREAS, the Department of the Interior and Local Government Memorandum Circular 2018-194 dated November 6, 2018 stated that cognizant of the important role of the barangay in the overall development and transformation of the community and of the nation, the Department undertakes to implement the Seal of Good Governance for Barangay (SGLGB) to encourage and challenge barangays to scale up its performance and practice of good governance that accord primacy to the principle of accountability, transparency, performance and effectiveness;

WHEREAS, the SGLGB is an award and incentive program for performing barangay governments in the areas of Peace and Order, Financial Administration, Disaster Preparedness, Social protection, Business-Friendliness and Competitiveness and Environmental Management and shall institutionalize a system of recognition and incentive awards for barangay governments and to provide mechanics for possible access to the Performance Challenge Fund (CF) and other incentive mechanisms available;

**NOW THEREFORE, I, ANTONIO V. MARIANO**, Municipal Mayor of Marcos, Ilocos Norte by virtue of the power vested in me by law, do hereby order the organization of the Municipality Performance Assessment Team for the CY 2023 Implementation of the Seal of Good Local Governance for Barangay (SGLGB).

**SECTION 2. Roles and Responsibilities:** The Municipal Perfomance Assessment Team (MPAT) shall perform the following functions:

- 1. Assess the performance of the barangays based on the indicators in the Data Capture Form (DCF, SGLGB Form 2) vis-à-vis the submitted Means of Verification (MOVs) of the Barangays;
- 2. Sign and certify as to the correctness of the DCF;
- 3. Approve and sign the Municipal Consolidated Performance Assessment Form (CC/M CPAF, SGLGB Form 4); and
- 4. Ensure the completion of the assessment, certification and encoding within the secheduled timeframe.

The Municipal Planning and Development Office as Secretariat of the MPAT shall perform the following functions:

- 1. Ensure the completeness of all MOVs of barangay entries based on the submitted Documentary Checklist;
- 2. Ensure the completeness of all MOVs of barangay entries based on the submitted Documentary Checklist;
- 3. Present to the CC/M PAT, during the assessment meeting meeting, all submitted form 1 and MOVs of barangays;
- 4. Accomplish the DCF (SGLGB Form 2) based on the assessment of the MPAT;

- 5. Facilitate the accomplishment and signing of CC/M CPAF by the MPAT;
- 6. Submit the signed CC/M CPAF to the Provincial Performance Assessment Team (PPAT); and
- 7. Encode the assessment data of all barangays in the SGLGB Google Sheet based on the DCF signed by the MPAT.

The MLGOO as Coordinator shall perform the following functions

- 1. Perform quality check of all barangay entries, by ensuring that all MOVs and forms submitted are true and correct;
- 2. Ensure that the MPAT and its Secretariat have complied with all the process requirements in the assessment of their barangays; and
- 3. Assist the MPAT in coordinating the SGLGB concerns.

**SECTION 3. REPEALING CLAUSE.** All executive orders, rules and regulations and other issuances or part thereof inconsistent with this Exectuive Order hereby repealed and modified.

**SECTION 4. EFFECTIVITY**. The executive order shall take effect immediately upon its approval.
